All prices quoted are exclusive of VAT.

The contracting party acknowledges that the Fair Participation Terms and Conditions and the General Terms and Conditions, as amended from time to time, shall apply in full to this agreement, including in particular the provisions regarding the temporally unlimited use of images, videos, brands, products and media by Carp Austria for the exhibitor as well as for the brands registered, represented or exhibited by the exhibitor. The Fair Participation Terms and Conditions and the General Terms and Conditions are available at www.carp-austria.com. Actual knowledge of the Fair Participation Terms and Conditions and the General Terms and Conditions by the contracting party is not required for their validity. The place of jurisdiction and place of performance for both parties shall be Graz. Angling Entertainment – Tatjana Kreinbacher, Straßganger Straße 120 A, 8052 Graz, Austria.

Terms and Conditions of Participation – CARP AUSTRIA 2026

The Terms and Conditions of Participation form an integral part of the Exhibitor Rental Agreement and shall become fully legally binding upon signature of the application by the Exhibitor. In addition, the General Terms and Conditions of the Organizer, Angling Entertainment, as well as the house rules of Arena Nova BetriebsgmbH, shall apply.

1. Opening Hours of the Exhibition

CARP AUSTRIA 2026 will take place on **Saturday, 5 December 2026, from 8:00 a.m. to 5:00 p.m.**, and on **Sunday, 6 December 2026, from 9:00 a.m. to 3:00 p.m.**

Following the close of the exhibition, all stand areas must be cleared and left in a clean, broom-ready condition. Dismantling of exhibition stands prior to 3:00 p.m. on Sunday is strictly prohibited.

2. Stand Rental – Payment – Early Bird Rate

2.1. The Early Bird Rate shall apply only if the written application is submitted no later than 31 July 2026 and 25% of the booked exhibition space together with ancillary costs have been re-ceived in our designated bank account no later than 31 July 2026. Failing compliance with these conditions, the standard rate shall automatically apply.

2.2. For stand applications submitted on or after 1 August 2026, 25% of the booked exhibition space together with ancillary costs shall be due immediately upon application. In all cases, the remaining balance must be received no later than 1 October 2026 in the following account:

2.3. In business-to-business transactions, all agreed prices and issued quotations shall be subject to value adjustment. Should the Consumer Price Index 2024 (VPI 2024) published by Statistics Austria increase by more than 6.5% compared to the base index of January 2026, Angling Entertainment shall be entitled to unilaterally adjust the agreed prices to the extent of the percentage exceeding the 6.5% threshold.

2.4. In the event of late payment, default interest at a rate of 12% per annum shall be charged.

Application and Cancellation

Applications must be submitted exclusively using the official form issued by the exhibition management. Upon submission, the application shall be binding upon the Exhibitor and may not be withdrawn. Withdrawal is excluded even if the exhibition management cannot fully accommodate the Exhibitor's requested stand size or type. In the event of cancellation, the Exhibitor shall pay the following cancellation fees: 25% up to 12 weeks prior to the exhibition, 50% up to 8 weeks prior to the exhibition, 100% from 4 weeks prior to the exhibition.

4. Admission

Admission as main exhibitor or co-exhibitor shall be decided exclusively by the exhibition management. Acceptance of the application shall be effected by issuance of the down payment invoice. The exhibition management reserves the right to reject applications without stating reasons.

5. Allocation of Space

Stand allocation shall be determined by the exhibition management. During stand construction, all instructions issued by the exhibition management must be strictly observed. Walls and floors of the halls must not be painted, glued, or otherwise damaged. The rented space must be maintained by the Exhibitor in proper and clean condition.

6. Exhibitor Passes

Exhibitor passes shall be issued in accordance with the booked stand area and shall entitle the holder to access the exhibition premises during official opening hours. Two exhibitor passes shall be issued per 9 m² of stand space.

7. Advertising on the Exhibition Grounds

Printed materials and promotional items may be displayed or distributed only within the rented stand space and not on the rear walls of the allocated stand, in aisles, or elsewhere on the exhibition premises. Only exhibition-related advertising measures of the Exhibitor are permitted, provided they comply with applicable laws and standards of decency and do not have ideological or political content. Comparative or superlative advertising is prohibited. Optical, moving, or acoustic advertising outside the rented stand space is not permitted.

8. Subletting / Co-Exhibitors

Rented exhibition space may not be sublet or otherwise transferred to third parties in any form. A co-exhibitor is an exhibitor represented with its own commercial goods on the stand of the main exhibitor with the prior consent of the exhibition management. The main exhibitor must declare co-exhibitors upon application. Co-exhibitors are required to complete the official co-exhibitor registration form.

9. Liability of the Exhibitor for Personnel

Each Exhibitor shall be fully liable for the conduct of its personnel, including theft, damage to property, or other misconduct. The Exhibitor is responsible for proper registration of all employees and temporary staff and for compliance with all applicable labor and social security regulations. Any third-party claims arising from violations committed by the Exhibitor or its personnel shall be borne by the Exhibitor, who shall indemnify and hold the Organizer harmless.

10. Liability and Insurance

Participation is at the Exhibitor's sole risk. The Organizer assumes no custody, safeguarding, or security obligations. No insurance coverage shall be provided by the Organizer. Any liability of the Organizer – irrespective of legal grounds – is excluded. This applies in particular to theft, loss, damage, or destruction of brought-in or parked property (including vehicles and stand equipment), personal injury, property damage, financial loss, consequential damages, loss of profit, business interruption, and damages resulting from defects in buildings or facilities.

The Organizer shall be liable solely for damages proven to have been caused intentionally by the Organizer or its vicarious agents. Liability for slight or gross negligence is excluded to the extent legally permissible. The burden of proof for intent lies with the injured party.

Any liability, if established, shall be limited in amount to the net stand rental fee of the respective Exhibitor. The Exhibitor shall be liable for all damages caused by itself, its employees, agents, or installations and shall fully indemnify and hold the Organizer harmless.

Claims must be asserted in writing without delay, failing which they shall be forfeited. Overnight stays in the halls or on the outdoor premises are prohibited.

11. Vehicle Traffic, Parking Prohibition, Vehicle Inspection

During exhibition hours, general parking is prohibited within the exhibition grounds. Vehicles may access the premises only outside official opening hours.

The Exhibitor expressly agrees that the interior of vehicles may be inspected at any time by the exhibition management or its authorized agents.

12. Fire Safety and Technical Safety Regulations

Hydrants, fire extinguishers, electrical control panels, gas shut-off valves, escape routes, and similar safety installations must not be obstructed or impaired. The use of open flames, liquefied gas, welding equipment, or spark-producing machinery within the halls is strictly prohibited. All decorative materials used for exhibition stands must comply with applicable fire safety regulations. Smoking is strictly prohibited in all exhibition halls of Arena Nova BetriebsgmbH.

13. Instructions of the Exhibition Authorities

Exhibitors shall grant the Organizer and Arena Nova BetriebsgmbH access to their stands at all times. Exhibitors must comply with all instructions issued by the authorized representatives. In the event of non-compliance, the exhibition management reserves the right to order the closure and clearance of the stand.

14. Stand Clearance

Dismantling of stands prior to the official end of the exhibition is prohibited.

Stand clearance must be completed no later than the day following the close of the exhibition. Failing this, the exhibition management shall be entitled to remove and store the goods at the Exhibitor's expense. All exhibition spaces must be returned to the lessor in the same condition as received upon expiry of the clearance period.

15. Electricity and Water Supply

Electricity requirements must be specified in the application form. The necessary contractual documentation will then be provided to the Exhibitor. Any water supply requirements must be coordinated in advance with the exhibition management.

16. Complaints and Claims

Complaints regarding the size, design, or allocation of exhibition space, as well as electricity or water connections, must be submitted to the exhibition management during the exhibition; otherwise, all related claims shall be excluded. Any other claims must be submitted to the exhibition management no later than the end of the event. Claims asserted thereafter shall be deemed time-barred. Any agreements shall be valid only if made in writing.

17. Price Labelling

All exhibited goods, price lists, and catalogues must display prices in euros (€) and inclusive of VAT. Price labelling must comply with the applicable statutory provisions in force in Austria.

18. Stand Design and Presentation

Stand allocation shall be determined by the exhibition management, whose instructions must be observed. Stand designs that conflict with standards of good taste or the overall appearance of the exhibition may be required to be modified. In case of refusal, the exhibition management shall be entitled to carry out such modifications at the Exhibitor's expense. Each Exhibitor must display its company name on the stand as instructed by the exhibition management. The rented stand must be occupied no later than 30 minutes prior to visitor opening hours on each exhibition day and must remain properly staffed and equipped for the entire duration of the exhibition. Upon vacating the stand, the Exhibitor shall return it in the same condition as received.

19. Non-Smoking Protection in Public Premises

Pursuant to the Austrian Tobacco Act (§12 and §13), smoking is prohibited in public indoor premises. This applies to all exhibition areas, including during set-up and dismantling periods. Smoking is permitted exclusively in designated smoking areas.

20. Exclusion of Liability – Games of Chance and Promotions

Games of chance, raffles, prize draws, or similar activities conducted solely for the purpose of collecting addresses are prohibited. The sale of lottery tickets or comparable activities is permitted only with prior written approval of the exhibition management. The Organizer assumes no liability for prize draws, raffles, or games of chance conducted by Exhibitors or third parties. Exhibitors conducting such activities are solely responsible for compliance with applicable legal regulations. Violations of these provisions may result in immediate exclusion from the event.

22. Image, Video and Media Usage

The exhibitor agrees that Carp Austria may use and publish photo and video material of the exhibition stand, products, brands, logos, advertising materials and overall trade fair presence for trade fair promotion, exhibitor promotion, the website, social media, press relations and editorial articles in the Carp Austria Fishing Magazine. This also applies to material created, selected or independently obtained by Carp Austria. The use is granted for an unlimited period of time, without territorial restriction and without any entitlement to payment, remuneration or compensation. The exhibitor confirms that they are authorised to grant this consent also for the brands, products, logos and advertising materials represented or exhibited by them. The exhibitor shall be the sole contact person for Carp Austria regarding any questions, approvals, objections or claims relating to image, video, brand, product, logo and advertising rights. Published exhibitor profiles, news articles and magazine articles do not have to be deleted after the exhibitor status has ended and may remain online marked with a notice such as "former exhibitor" or "currently not an exhibitor".

22. Stand personnel

The exhibitor shall be responsible and liable for their stand personnel as well as for all persons deployed by them at the exhibition stand.

The place of performance for all obligations arising from participation in or attendance at the exhibition shall be Graz, Austria. The exclusive place of jurisdiction for any disputes arising out of or in connection with this contract shall be the competent court in Graz, Austria.

By signing the application, the Exhibitor acknowledges and accepts these Terms and Conditions of Participation as well as the General Terms and Conditions without reservation.

In the event of any discrepancy or inconsistency, the German version shall prevail and be legally binding.
